Ltd. must then provide this information to you within five (5) business days of receiving your written request. If Seafood Express (P.E.I.) Ltd. has not yet received the requested information from the previous employer(s), then the five-business days deadline will begin when Seafood Express (P.E.I.) Ltd. receives the requested safety performance history information. If you have not arranged to pick up or receive the requested records within thirty (30) days of Seafood Express (P.E.I.) Ltd. making them available, Seafood Express (P.E.I.) Ltd. may consider that you have waived your request to review the records.
